In order to act on your behalf, we will require the following documents. An explanation of each document is provided below, along with answers to common questions; however if you require further clarification; please do not hesitate to contact us directly:

.. **Credit Application**

All information provided is held in the strictest confidence. You may provide your own credit reference; however please sign & return ours too – it provides us authorization to contact your bank.

.. **Power Of Attorney (“POA”)**

The Power of Attorney is a legal document authorizing BILSI and its agent to represent you, (the exporter or importer) in all matters relating to importing of products into the US. Two signed copies are required, one will be returned for your records.

.. **Corporate Certification**

This certification ensures that the individual who signed the Power of Attorney on behalf of the corporation is authorized to execute it on behalf of the company by authority of its governing body; through its Articles of Incorporation, Charter, by-laws or resolutions.

.. **Account Security (BOND)**

BILSI can arrange for a US Bond that will enable U.S. customs release of your shipments prior to payment of duties. If you have imported from countries (other than Canada) into the U.S. previously; that same bond can be used.

.. **Request for a EIN Number**

To import to the U.S., an Employer Identification Number (EIN) is needed, An EIN is known as a federal tax identification number and is used to identify a business entity. Refer to: [Employer ID Numbers \(EINs\)](#) for more information.
